Properties:

Consists of natural raw materials such as carnauba wax and is used as primary and routine maintenance on varnished, waxed and oiled floors, furniture finishes, etc.. It protects against dirt and mechanical wear. NAPLANA 2085 is also suited for smooth leather and other finishes. Following a short drying time, results in a satin sheen finish without polishing. The treated surfaces are rejuvenated, are diffusion-capable, and dirt-repellent.

NAPLANA Care Emulsion Plus additionally gives the finish anti-slip effect.

Use sparingly on smooth stone surfaces. Regular maintenance will dramatically extend the service life of the floor. After drying, NAPLANA 2085 can be polished out further by machine.

Attention: When using over extended periods, observe the correct dosage. An unpleasant, difficult to remove wax layer may form otherwise.

Water, carnauba wax, emulgator, lavandine oil (contains linalool), bergamot oil (contains limonene). NAPLANA plus anti-slip additionally contains micro-wax.

Application:

Newly treated floors should first be cleaned with NACASA Universal Cleaner 4010 no sooner than after 4 weeks. Then apply a thin and even coat of NAPLANA (1 cap from the 1 liter bottle or 20 ml on 1 l of lukewarm water) with a lint-free rag or floor scrubber. The subsequent maintenance intervals are based on the traffic load of the floors. Concentrated to pure NAPLANA 2085 can also be used on smooth leather and other finishes.

Attention:

Polished finishes tend to be slippery! Test before use and arrange for test surfaces as needed! Start by thoroughly cleaning substrates with NAPLANA prior to each application. Do not overdose NAPLANA as this may result in streaks and a slipping hazard!
